Nem-Pak reserves the right at its discretion to increase the customer's credit limit upon request by Customer, but such increase shall not affect other provisions of the agreement. All applications approved for credit are governed by the following.

- 1. An account which has a past due balance or exceeds or will exceed an established credit limit may be subject to future shipments on a C.B.D. or C.O.D. basis. Nem-Pak also reserves the right to withhold shipments to customers whose credit accounts are past due.
- 2. The foregoing information and accompanying financial statement are correct and were provided to induce Nem-Pak to extend credit to Customer.
- 3. If the account is not paid according to its terms and is referred to an attorney for collection, Customer agrees to pay all costs and expenses of collection, including reasonable attorney's fees.
- 4. Customer must give Nem-Pak advance notice of any change in the business structure or ownership. Without such notice, and Nem-Pak's express acknowledgment and approval, Customer and the original principals to whom credit was extended shall remain liable on the account. Notice hereunder shall be given by certified or registered letter and acknowledged by return receipt.
- 5. Credit policies are subject to change at the discretion of the Credit Department of Nem-Pak. Upon the acceptance of the application, and the issuance of an open line of credit, Customer agrees to abide by the credit policies of Nem-Pak and further agrees to abide by all terms and conditions of this Credit Application.
- 6. Nem-Pak requires a valid customer purchase order for each order.
- 7. NEM-PAK'S PAYMENT TERMS ARE NET 30 DAYS FROM DATE OF INVOICE. ANY PAST DUE INVOICES SHALL BEAR INTEREST AT THE RATE OF 1.5% PER MONTH OR THE HIGHEST RATE PERMITTED BY LAW, WHICH IS LESS.
